## Guidance for Entries

Please provide information to support your application (maximum 1,500 words). All nominations for the 2025 Campaign will again be assessed against the priorities of the NABMA #MarketsFirst Campaign. The below is a checklist of what the judging panel will look for.

- Initiatives and successes in retaining and attracting new traders
- Providing evidence of new business startups and their sustainability
- The added value of how the market supports the local town, city centre or local community
- If available, provide evidence of footfall
- Tell us about your marketing and publicity campaigns with examples of successes
- How you engage with young people and encourage young entrepreneurship
- Successful partnerships and funding bids
- Good practice in promoting relationships between operator and traders
- Anything else that makes your market stand out

A large market is considered to have 50+ stalls, a small market is considered to have less than 50 stalls.

Please Note - that nominations must be for the correct category as insufficient evidence or entries in the wrong category will not be considered. The judges' decision to be final and no correspondence or discussions will be entered into.



# BRITAIN'S FAVOURITE MARKET

The vote for “**Britain’s Favourite Market**” is set to launch at **12 noon on Thursday, 31st October, 2024**. This annual initiative, an integral part of the Great British Market Awards, calls upon market operators, traders, and the general public to nominate and vote for their most beloved markets.

One key message is clear – any market can emerge victorious in this competition. The final winner will be selected from the list of category winners, in conjunction with the public vote, and the evaluation process may involve mystery shops and quality assessments by the judging panel. The essence of “Britain’s Favourite Market” is deeply rooted in the experiences of the people who visit these markets and the dedication of the traders who make them special.
